## **Rules & Regulations:**

1. The Miss Pre-Teen Bluegrass Fair Pageant is open to residents of all counties in Kentucky. Young ladies who have been crowned Miss Pre-Teen in another county fair contest in 2009 are ineligible.
2. A contestant must have reached her 8th birthday by July 1, 2009, and cannot have reached her 13th birthday by October 31, 2009. A contestant must be a full time student in an accredited Kentucky School System.
3. Miss Pre-Teen Bluegrass Fair will represent the Lexington Lions Club Bluegrass Fair at the Miss Pre-Teen Kentucky County Fair competition held in Louisville in the fall.
4. Contestants will be judged on beauty, poise and presentation. They may wear formals, but no heavy sequins or heavy makeup. Hair styles should be age appropriate.
5. There will be individual interviews prior to the pageant. Contestants may wear sportswear, but no short shorts. Walking length shorts or skorts are permissible. The interview will count for half of the total score. Interview questions will be based on the contestant's application.
6. The contestant may be sponsored by a business, an organization, or by her parents or other family member. The registration fee of \$20 must accompany the application or be in the hands of the pageant committee by the time of the rehearsal or the contestant will not be permitted to participate.
7. A winner, two runners up and an interview winner will be selected.

**PLEASE NOTE: Interviews will be conducted in the air-conditioned comfort of the Fayette County Extension office off Red Mile Road. You may arrive as early as 1:15 p.m. Interviews will begin at 2 p.m. There is ample restroom and dressing space in this facility. The on stage portion of the pageant will continue to be at the Fairgrounds at Masterson Station Park -- just a short drive from the Extension Office (a map is provided). Contestants may park and enter the fairgrounds from Gate 1. You may park in the Lions Club lot on the left adjacent to the fair entrance. Only the contestant and one adult chaperone will be admitted free. All others accompanying the contestant must pay the \$5 gate admission.**

\*While contestants are encouraged to attend the rehearsal, those coming from significant distances may be not able to do so. If you have any doubts about your ability to attend the rehearsal, please be certain your entry fee accompanies your application. Please notify Sue Alexander at (859) 266-6969 if you are not going to be able to attend the rehearsal so that information can be provided to you.

Drawing for contestant numbers takes place among those who attend the rehearsal. Those unable to do so are assigned contestant numbers following those who attend the rehearsal. This gives these contestants an opportunity to observe the format of the pageant before having to go on stage.

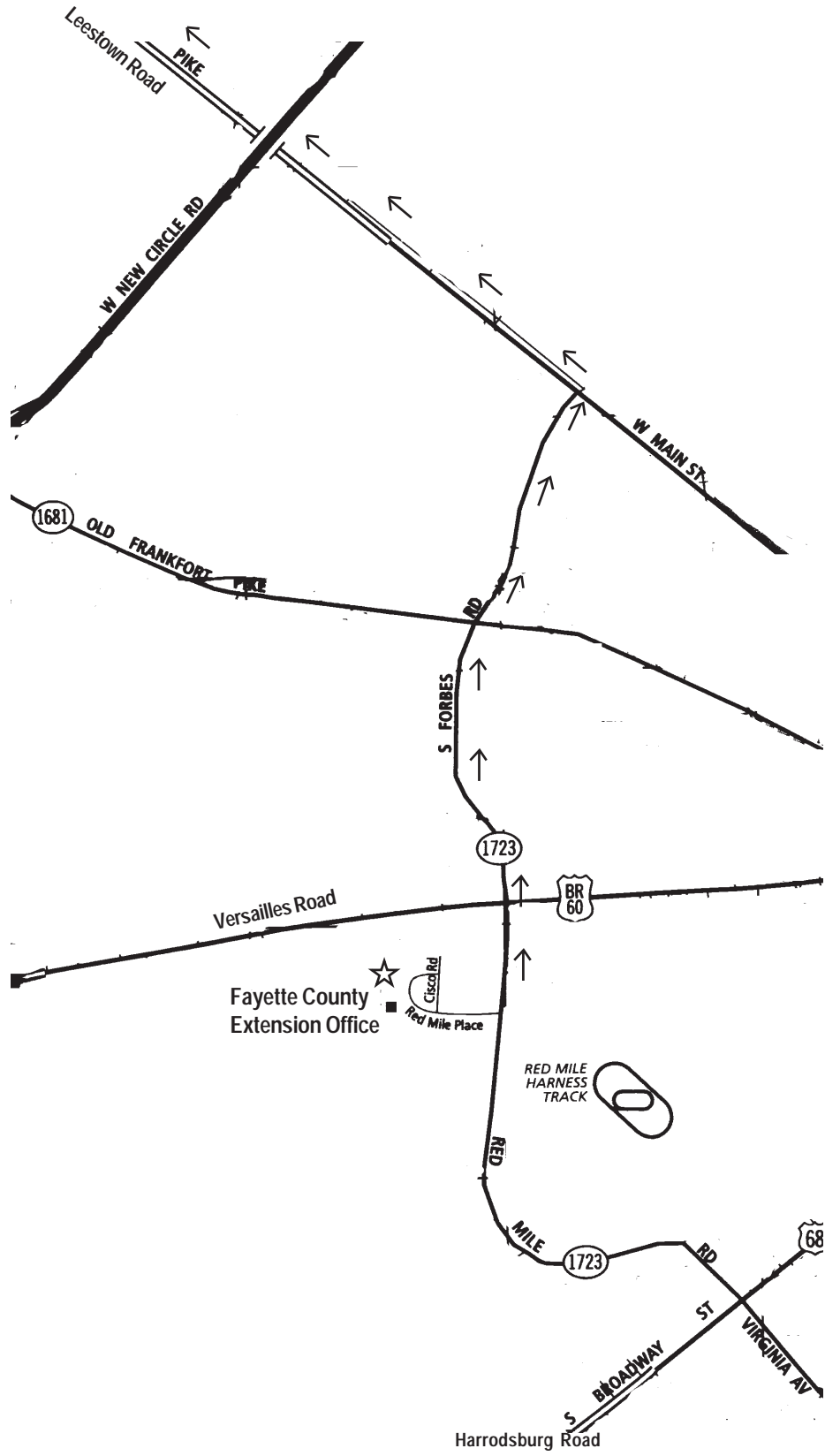

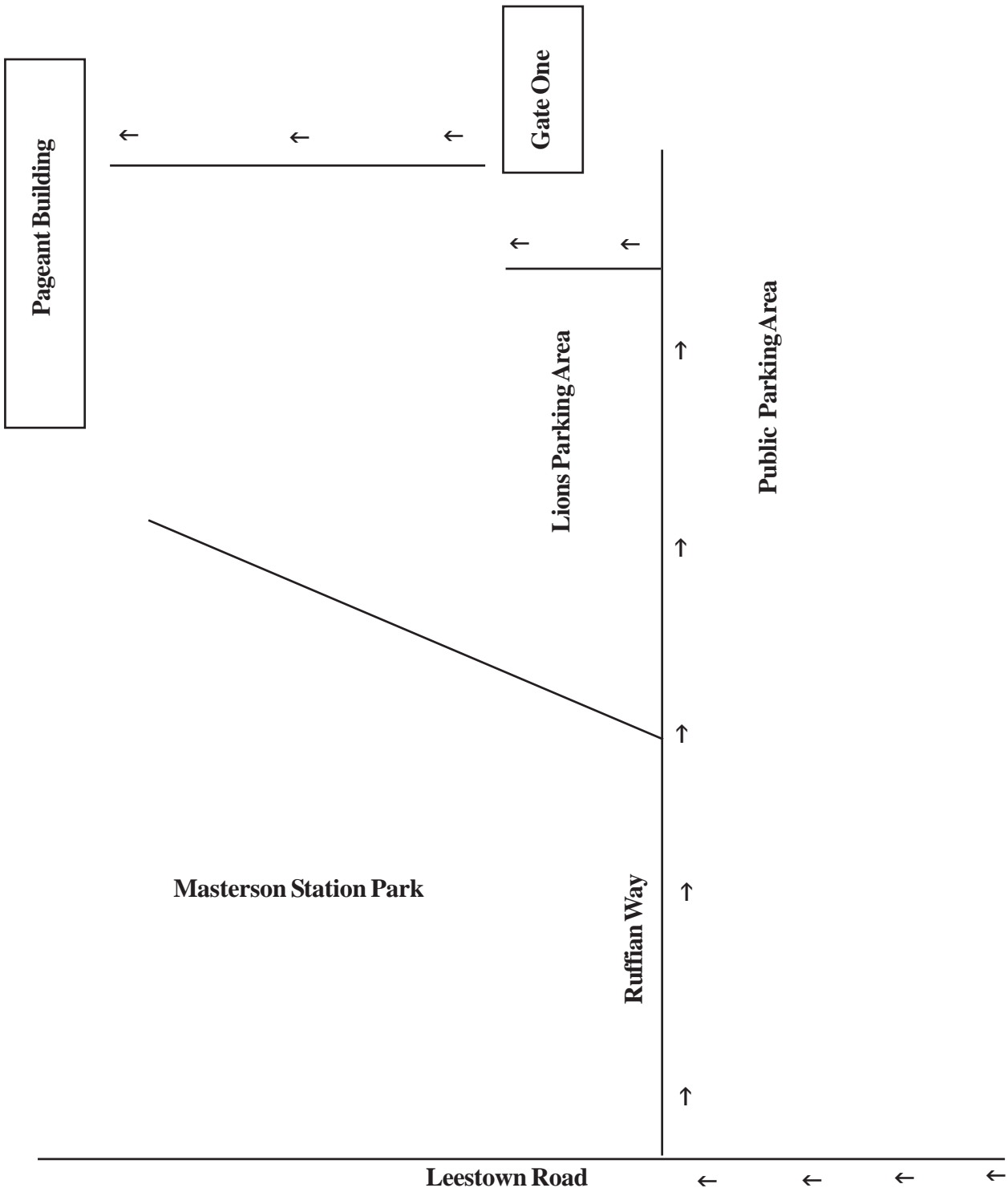

**Park in the Lions Parking Area. The attendant will be instructed to permit you to park in this area. It is the closest you can park to the entrance gate. The pageant contestant and one other person will be admitted free. All others must pay the \$5 gate admission. The building where the pageant is to be held is a straight walk down the Main Street of the Fairgrounds. This will be the way you enter for rehearsal as well as the pageant itself. It represents a change from previous years. Gate 2 will not be open on the pageant nights.**
